

# **CAMPING DU BOIS JOLI**

## **INTERNAL REGULATION OF THE CAMP-SITE DU BOIS JOLI**

### **1 -STAY AND ADMISSION REQUIREMENTS**

The manager during registration in the evening between 6 pm and 8 pm will judge compliance with the campsite's internal rules.. Moreover, it agrees the right to accept or refuse the stay on the ground.

The fact of remaining on the camp-site implies the acceptance of the provisions of this regulation and the commitment to conform to it.

Any infringement will be able to involve for its author a procedure of expulsion, with recourse to the police so necessary.

### **2 - FORMALITIES OF POLICE**

Any person having to remain at least a night in the camp must as a preliminary present to the person in charge of the Reception Office (or to manager) her identification papers.

### **3 -INSTALLATION**

The tent, caravan or the motor home and related equipment must there be installed on a free site indicated by the plan numbered at the entrance of camp-site. This will be validated by the manager between 6 pm and 8 pm.

### **4 -RECEPTION OFFICE**

Open from Monday to Sunday, registration from 6pm to 8pm and apart from these schedules a number of portable is communicated on the panel at the entrance of camp-site.

The camp-site is open from May 1st to September 15th.

One will find at the Reception Office all the information on the services of the camp-site, information on the possibilities of supply, the sports facilities, the tourist wealths of the surroundings and various addresses which can prove to be useful.

### **5 -POSTING**

This rules of procedure as well as the prices of the various services are displayed at the entrance of campsite and Reception Office.

### **6 -ROYALTIES**

The royalties are paid at the Reception Office. Their amount is fixed according to the rates. They are due according to the number of nights spent on the ground. The campers are invited to prevent the Reception Office of their departure as of the day before this one.

The campers intending to leave before the opening hour the Reception Office must carry out the day before the payment of their royalties.

### **7 -NOISE AND SILENCE**

The users of the camp-site are urged to avoid all rustled and discussions which could obstruct their neighbors.

The sound devices must be regulated consequently. Closings of the doors and E trunks must be as discrete as possible.

The dogs and other animals should never be left in freedom. They should not be left on the spot, even locked up, in the absence of their Masters who of it are civilly responsible. The legislation in force on the dogs considered to be dangerous must be formally respected.

Silence must be total between 22:00 and 7:00.

### **8 -VISITORS**

The visitors can be allowed under the responsibility of the campers who receive them.

If they use the services put at the disposal of campers, the owner can claim the price of those to them.

## **9 -CIRCULATION AND PARKING OF THE VEHICLES**

Inside the camp-site, the vehicles must run at a speed limit of 10 km/h.

Circulation is prohibited between 22:00 and 7:00.

In the camp only the vehicles can circulate which belong to the campers remaining there. The parking does not have moreover, to block circulation nor to prevent the installation of new arrivals.

## **10 -BEHAVIOUR AND ASPECT OF THE INSTALLATIONS**

Each one is held to abstain from any action which could harm cleanliness, the hygiene and at the sight of campsite.

It is interdict to throw the water polluted on the ground.

The household refuse, waste of any nature, papers must be deposited in the container located at the exit of the camp-site.

Washing is interdict apart from the vats envisaged with this use.

The plantations must be respected. It is interdict with the camper to plant nails in the trees, to cut branches, to make plantations. It is not allowed either to delimit the site of an installation by average staffs nor to dig the ground.

Any degradation made with the vegetation, the fences, the ground or the installations of the camp-site will be the responsibility of its author.

The site which will have been used during the stay will have to be maintained in the state in which the camper found it at his entry in the places.

## **11 -SECURITY**

Protection of health: the dogs and the cats could not be allowed on the ground that on presentation of a certificate of vaccination against the rage.

fire: open fires (wood, coal...) are rigorously prohibited. The stoves must be maintained in good state of operation.

The barbecues with gas are authorized, the electric barbecues are prohibited.

The extinguisher is at the disposal of all. In the event of fire, to immediately warn the person in charge of the Reception Office to

the 06 43 00 43 47.

**FLIGHT:** The camper keeps the responsibility for his own installation and must announce to the person in charge the presence of any suspect person. The campers are invited to take the usual precautions for the safeguard of their equipment.

## **12 -GAMES**

No violent or awkward game can be organized near the installations.

The medical ones cannot be used for the animated games. The children must always be under the surveillance of their parents.

The playground must be respected and kept in good state of operation.

## **13 -DEAD GARAGE**

It could be left of equipment nonoccupied on the ground, only after agreement of the direction and only with the site indicated. This service will be invoiced.

## **14 -SANCTIONS**

In the event of deterioration of goods by the users of the camp-site or the visitors, the expenses of repairing will be invoicees.

If a resident would disturb the stay of the other users or would not respect the provisions of this rules of procedure, the manager will be able orally, if he considers it necessary, to carry out the expulsion of this last.
